JAKE LABARRE, AIA Miller Hull Partnership, LLP

Jake LaBarre is an architect and educator. He began working with the Miller Hull Partnership in 2010, working with founding partner Bob Hull in 2013 on the Community Life Center for Bethany Community Church, which houses a daycare, foodbank, and ministry space. Jake brings a focus on constructability and detail to his work with Miller Hull. With a background in construction, he encourages attention

to project management and goals, while maintaining a balanced design with rigorous schedules and budgets.

Jake has also engaged in faith-based outreach through his teaching at the University of Washington's Neighborhood Design Build Studio. Each year, the studio designs and builds small projects for local community groups, including the Woodland Park Community Preschool at the Fremont Baptist Church and Child Learning and Care Center at the University Congregational Church. Jake was the 2016-2017 Visiting Assistant Professor at the internationally recognized Rural Studio of Auburn University, where he led a group of students through design and construction of a home in a rural Alabama community. Jake is involved in a variety of project scales and encourages active design conversation with his collaborators, whether it is in the classroom, in the office,

Larry has served as the Cathedral's Pastoral Assistant for Administration since 1995. Prior to that he served on the Parish Pastoral Council and Finance Councils from 1987 to 1992. He received his Bachelor's degree from Seattle University where he also pursued graduate studies.
